Please Note:

This guide to the Timor papers of David Scott is largely based on a preliminary box list quickly prepared by me in a single sitting at David's home in 2004.

The papers were later deposited at the University of Melbourne Archives (UMA) by David Scott in 2006.

At the invitation of UMA, the papers were re-examined by Cecily Gilbert and me on 07 June 2011. We adjusted the box numbering to reflect UMA's reboxing of the original cartons deposited by David Scott. We also recorded the contents of some folders not available to me in 2004 (see boxes 9-10)

The June 2011 examination also indicated some folders or folder content may have been relocated or removed sometime between 2004 and when the material was deposited at UMA. Further work will be done on the collection later in 2011 to make this list a more accurate representation of the collection's contents.

Box Number

All folders in this collection are located in ten numbered standard archive boxes.

Folder Number

A running sequence of numbers for easy folder identification from the printed list. They are composite numbers based on their original carton number (when deposited by David Scott) and the folder sequence in the original carton [Example: 6-3 was the third folder in Carton 6 as deposited; this list shows item 6-3 is now in University of Melbourne Archive Box 7]. These numbers are recorded in pencil on the front of the folders.

Folder Title

Folder Titles are used to physically identify individual folders in a given box. Titles were recorded directly from folders without correction. Many folders have multiple titles (effectively used by DScott as his guide to folder contents); multiple titles are separated here by a slash (/).

Size

Indicates thickness of folder or other container. Recorded to the nearest half centimetre as a rough guide to amount of material in container. 0.0cm indicates size was not measured.

Date Range

Expressed in years to describe the earliest and latest year on contents of a given folder. These should be seen as guides rather than accurate statements. Where year is uncertain, this is recorded as '0'.

Content Summary

Only a rough guide to contents of folder. In this collection, much of the content detail is described in the 'Item Listing'. This descriptive area may also contain some clarifying notes on folder titles, location, state etc of the material.

Item Listing

Lists the detailed contents of a folder; may include individual documents and/or groups of items. Listing is somewhat selective and should be seen as a non-exhaustive. Numbers indicate order of items in folder as found in December 2004.

Item Year

Indicates year or year range of individual entries in item listing; left blank when not recorded or year is uncertain.
